The Center for Governmental Training and Technology in the Mississippi State University Extension Service is pleased to sponsor the 2012 Spring IAAO School this coming March 5-9, 2012. The IAAO courses being offered are 101: Fundamentals of Real Property Appraisal and 300: Fundamentals of Mass Appraisal. We have a great lineup of instructors too! Course 101 will be taught by Mr. Larry Ellis, CAE from Johnsonville, TN and Course 300 will be taught by Mr. Garth Thimgan, CAE from La Junta, Co.

In addition to the 2012 IAAO Spring School, the Center for Governmental Training and Technology will partner with the MS Chapter of IAAO to offer IAAO Course 112: Income Approach to Valuation II. Course 112 will be offered May 7-11, 2012. Course 112 will be instructed by Kenneth W. Voss, CAE from Atlanta, Georgia.

All three IAAO courses will be conveniently held at the Bost Extension Center in Starkville, MS. An information sheet with an Enrollment Form and course, lodging, and other information is enclosed. Photocopied Enrollment Forms will be accepted so feel free to pass this information around to deputies and other individuals within your office who did not receive a hard copy. The cost of enrollment is \$500 per course; however, please note that registration forms must be received two weeks before the start of the course to avoid a \$25.00 late fee charge. In addition, due to the amount of interest shown in these courses, a limited number of students (30) will be enrolled, so please register early.

The IAAO courses all qualify for Track II levels of certification within the Mississippi Education and Certification Program (MECP) either as required courses or electives. Please refer to *The Red Book* for details (find it online at [www.cgt.msstate.edu](http://www.cgt.msstate.edu)).

In addition to meeting the MECP's requirements, these courses also qualify toward achieving one or more of the five internationally recognized designations within the IAAO Professional Designation Program (PDP). These designations are listed in Table 6: IAAO Professional Designation Program, of *The Red Book* (please refer to [www.iaao.org](http://www.iaao.org) for more detailed information).

## *Courses & Course Descriptions*

### **Course 101: Fundamentals of Real Property Appraisal**

Fundamentals of Real Property Appraisal is designed to provide students with an understanding and working knowledge of the procedures and techniques required to estimate the market value of properties using two approaches to value: the cost approach and the sales comparison approach.

**Course instructed by Larry Ellis, CAE, of Johnsonville, TN. Course Date: March 5-9, 2012**

### **Course 300: Fundamentals of Mass Appraisal**

Course 300 provides an introduction to mass appraisal and is a prerequisite for the 300 series of courses offered by the IAAO. Topics covered include single-property appraisal versus mass appraisal, components of a mass appraisal system, data requirements and analysis, introduction to statistics, use of assessment ratio studies in mass appraisal, modeling of the three approaches to value, and selection of a mass appraisal system.

**Course instructed by Garth Thimgan, CAE, La Junta, CO. Course Date: March 5-9, 2012**

### **Course 112: Income Approach to Valuation II**

Income Approach to Valuation II is a comprehensive, interactive program intended for mid-level, commercial-industrial appraisers. The material will cover the income approach to value in depth, and reflect contemporary appraisal theory. The course will be broad based, while covering many topics that will focus on a case study problem that utilizes methodology learned in the course and will also allow the audience to work through the case study to its conclusion.

**Course instructed by Kenneth W. Voss, CAE from Atlanta, GA. Course Date: May 7-11, 2012.**

## *Tuition, Enrollment, & Class Schedules*

Tuition for each course is \$500 and includes a student reference manual. Recommended textbooks cost extra. Payment for tuition and any textbooks ordered should be made payable to the Center for Governmental Training & Technology.

Use the "IAAO Course Enrollment Form for Mississippi" to sign up for the IAAO School.

**Enrollment Forms for Course 101 and 300 should be submitted by February 13, 2012.**

**Enrollment forms for Course 112 should be submitted by April 13, 2012.** After payment is received, a confirmation letter will be sent to each student.

All classes begin at approximately 8:30 a.m. on Monday and end by 5:00 p.m. each day. Courses conclude with an examination on Friday morning. Individual instructors may deviate from this.

## *Additional Textbooks & What to Bring*

A student reference manual (SRM) is provided for each student enrolled; however, IAAO typically recommends an additional textbook. *Property Assessment Valuation* (PAV) is recommended for Course 101 and Course 112 - \$55.00. *Mass Appraisal of Real Property* (MARP) is recommended for Course 300 - \$50.00. Used or shared textbooks are acceptable for all courses.

When ordering a textbook, please mark the appropriate box on the "IAAO Course Enrollment Form for Mississippi." Also bring a silent calculator (battery-operated recommended) and appropriate writing materials including No. 2 pencils for taking the examination.

### *Lodging & Meals*

The Holiday Inn Express offers comfortable accommodations at a reasonable price. ### *Certificates of Completion / Certification*

This is an IAAO-Certified School with all courses taught by senior IAAO instructors holding at least one professional IAAO designation. IAAO certificates of completion will be issued to those who successfully complete the final examination for each course

Successful completion is accepted by the Mississippi Education and Certification Program Advisory Board and/or the IAAO Professional Admissions Committee as partial fulfillment of the educational requirements for Assessment Evaluator I (AEI), Assessment Evaluator II (AEII), and Mississippi Assessment Evaluator (MAE) certification and one or more of the following IAAO designations: Certified Assessment Evaluator (CAE), Residential Evaluation Specialist (RES), Cadastral Mapping Specialist (CMS), Personal Property Specialist (PPS), and Assessment Administration Specialist (AAS). All IAAO designations also require USPAP. Please contact IAAO for specific USPAP requirements.

### *Continuing Education Credit*

All appropriate appraisal related courses have been submitted to the Mississippi Real Estate Commission (MREC) for the appropriate number of Continuing Education (CE) credit hours. Students interested in CE hours for IAAO Courses should contact Taylor Casey 662-325-3141.

Students seeking CE credit are responsible for notifying their instructor on the first day of class and for following all MREC procedures.
